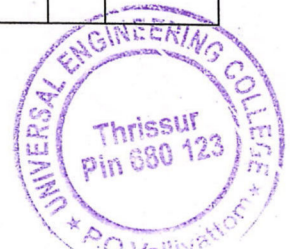

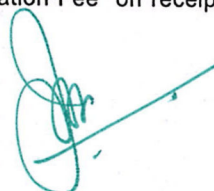

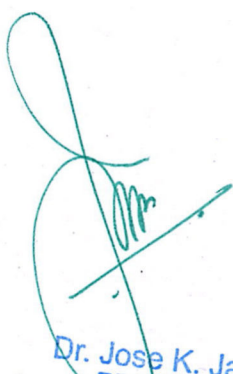
Non -compliance with any of the conditions will result in the withdrawal of the affiliation without any notice.
